Team competition rules - povzetek:

Same rules apply in the team competition Adriatic Cup and team competition Jiu-jitsu (ne-waza) – men and women alike, in respect to the JJIF Competition Rules, in weight categories from 56 to 94+.

Following rules shall apply also:

- Competitions are held in the SEN categories, juniors and U18 can also compete, but under the responsibility of the coach.
- a team shall have a min 4 to a max 12 athletes;
- each team is allowed to have two “guest” athletes (indicated at registration);
- in a match a team will meet other team (as decided by the draw), starting with athletes from lightest weight categories up;
- scoring shall follow JJIF rules, a tied score in individual match is possible (a draw is allowed, no match extensions or another rounds of fights);
- a team with more individual wins shall win the match. In case of same number of wins the following procedures shall be followed (in that order):
 - Counting the “full ippons” – a team with more “full ippon” shall be declared as a winner;
 - If that will not determine the winner, a special draw for one individual category to fight is made to determine a winning Team (tied score not possible any more, fushen-gachi possible – i.e. empty category in one team etc.).

Protocol of the Team Event:

- Announcement (presentations) of all teams (on the mat);
- Ceremonial bow (Rei);
- Start of Matches.
- Same procedures apply for awarding ceremony.

Schedule of the Team Event:

- Adriatic Cup jiu-jitsu fighting system up to semi-finales; Finals at the end.
- Jiu-jitsu (ne-waza) including finals;
- Women Cup – to be decided by the LOC upon number of registered teams.

Registration deadlines:

- Participation confirmation 14.2.25; Registration with team composition (by athletes) 24.2.25

Gold, silver and bronze medals in each category.

Fair Play Trophy will be awarded for sportsmen like behavior (provided by the JJEU).

VIII. REFEREES

Slovenian and guest referees with valid license. Ju-jitsu Federation of Slovenia shall appoint the Head Referee of the Tournament.

Each team is kindly requested to contribute at least one referee with a valid licence.

Organizer will provide lump-sum for referees in line with the national regulations (JJFS).

Referees will have free meals provided at the Sports Hall during the competition.
